7:00 p.m. Action on the minutes of the meeting of April 25, 2011 were delayed to the end of the public hearings.

7:05 p.m. **1385 Hancock St: Stop & Shop:**

Mr. Donald Agnoli of Agnoli Sign Co. of Springfield, MA represented the applicant. The proposal for a new sign on the Granite St. façade and the front door on Hancock St. are necessary because of the presence of Royal Ahold in the building and the re-organization of Royal Ahold and Stop & Shop Co. Member Hunt questioned the use of 'white' as a color for the royal Ahold piece. He thought it was inconsistent with the existing Stop & Shop logo and colors. He also thought that this sign resembled a building directory. K. Nugent said the Building Dep't. does not consider this a building directory. Mr. Agnoli indicated that the 'white' color was selected because it offered greater visibility. Member Fitzgerald made a motion to approve and was seconded by member Hunt. Chairman Ricci asked that Alt Verenis be allowed to vote. The vote was Members Ricci, Hunt , Fitzgerald, Verenis in favor. Members Jacobs and Manning abstained. .

7:15 p.m. **1223 Hancock St.: One Main Financial:**

The applicant was represented by Jason Paville of Back Bay Sign Co. The present tenant is re-organizing and has a name change. On a motion by Member Hunt, second by Member Jacobs, the application was approved as submitted by a 4-0 vote.

7:20 p.m **1429 Hancock St.: Korean Grille:**

The applicant was represented by Signature Signs of Weymouth MA. On a motion by Member Manning, second by Member Hunt, the application was approved as submitted by a vote of 4-0.

7:25 p.m. Minutes: The minutes of the April 25, 2011 meeting were read and unanimously accepted on a motion by Member Fitzgerald, second by Member Manning

7:30 p.m. Other Business:

1. Clarification was given about the South Coast rail project.
