**Agenda 1.** Hearing regarding the request of the Lions Club of Quincy for a One-day permit for the 14<sup>th</sup> Annual Run/Walk for Sight, Saturday April 23, 2011. Ms. Loretta McTiernan, present. The annual event will start and end at Pageant Field, no changes in the route. Motion to grant the request made by Commissioner Scheele, second Chief Keenan. All in favor.

**Agenda 2.** Hearing regarding the request for a One-day permit for the 2<sup>nd</sup> Annual "Just Because Walk" Sunday, May 22, 2011. Ms. Peggy Simone. Applicant not present. Postponed to a later date.

**Agenda 3.** Hearing regarding the request of New Mt. Calvary Greater Worship & Praise Ministries, Inc. for a One-day General Permit to host a Community Day, Saturday, April 16, 2011 Noon-6 PM on the grounds of The Bethany Church, 18 Spear Street. Bishop Lincoln Wright, not present. Commissioner Scheele motioned to have the License Board secretary to contact Bishop Wright @ the Bethany Church regarding his request, second Chief Keenan. **Agenda 4.** Hearing regarding the request of The Litre & Wedge Wine & Cheese Shop, Inc., d/b/a Point Liquors, 230 Washington St., for Transfer of Stock, New Officer/Directors & Change of Manager, from George Deschenes to Judith Deschenes. Attorney Jon D. Aieta and Judith Deschenes, present. Ms. Deschenes has 5 years experience at Point Liquors and will take over as President, Secretary, Manager & Director. The Board asked that she contact Lt. Turowski regarding TIP'S training. Motion to grant the request for Transfer of Stock made by Commissioner Scheele, second Chief Keenan. Motion to grant the request for New Officers & Directors made by Commissioner Scheele, second Chief Keenan. Motion to grant the request for Change of Manager made by Commissioner Scheele, second Chief Keenan. All in favor.

**Agenda 5.** Discussion of 527 Code of Massachusetts Regulations 10.13-Requirements of Crowd Managers for Nightclubs, Dance Halls, Discotheques & Bars, effective June 1, 2011. Board members were given the list of establishments with occupancy over 100. Chairman Shea noted the new State Mandate Code is effective June 1, 2011. Chief Barron noted this is straightforward similar to the Coconut Grove fire, it takes the Code one-step forward after the Rhode Island fire. Chairman Shea suggested the Board review the new Code, discuss its implementation, and return April 26. Commissioner Scheele motioned to continue the hearing regarding the Fire Code Directive until April 26 and establish a list, second Chief Keenan. All in favor.
